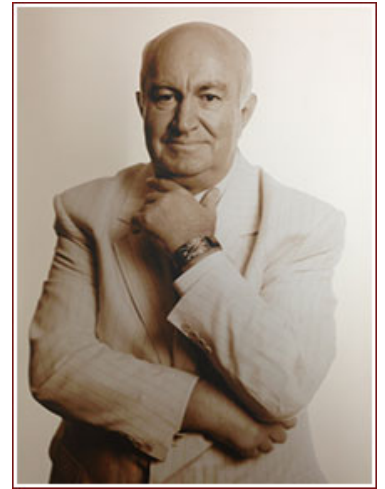


## International Conference “System of Labour Law and Social Security Law” (the 1<sup>st</sup> Gusov readings)

- Labour Law and Social Security Law as an integral part of the Russian legal system;
- national and international legal systems as regulators of relations in the sphere of labour and social security;
- codification of regulations on labour and social security as a way of systematization of law;
- system of sources of Labour Law and Social Security Law.

The working language of the Conference is Russian.
